# 1. Shipe Rd Rezoning 12-B-24-RZ




## What

34.1 acres

Currently zoned up to 2.5 units / acre Planned Residential

Initially requested 5; applicant now says 3 is what they need - <u>12-B-24-RZ</u>







### Issues

No traffic study at this phase

No requirement for schools, parks, road improvements

Professional staff recommended **DENIAL** 

Planning Commission approved


built at 5.3 units / acre

Rest marked "future development"

In the Rural Conservation Placetype

Will require improvements on Roberts Rd on both ends - Washington Pike and Emory Rd









### **Rural Conservation**

Rural Conservation areas are intended to conserve forested areas, ridges, wetlands, and other significant natural areas by clustering development and minimizing land disturbance. Generally, these areas conserve between 50-70 percent of a site as natural open space.

### **HOUSING MIX**

 Single family residential subdivisions shall be clustered in a pattern that preserves 50 percent or more open space on a given site







Conservation design (above, left) yields the same number of homes on a given parcel as a conventional subdivision design (above, right). The conservation design results in less pavement, shorter distances to run utilities, and greater open space preservation.





### Issues

No tree or soil protection plan

No conservation plan for "undisturbed open space"

Clearly Smithbilt is hoping they will be able to use more of this property in the future for houses



The East Knox County Mobility Study is a community-focused initiative designed to enhance transportation planning for the Gibbs, Corryton, Ritta, Strawberry Plains, and Mascot areas. The study will integrate transportation best practices and consider all modes of travel. By identifying key transportation programs and projects, this study aims to accelerate progress toward the communities' transportation goals. The final result will be a comprehensive transportation strategy that supports a safe, vibrant, and connected East Knox County.

### **East Knox County Study Area**



plans to identify past proposed projects, such as greenway, road widening, safety, and sidewalk projects.



#### Safety Assessment

The team will review the last 5 years of crash reports to identify high-risk areas.



#### Stakeholder Engagement

Bringing together a group of vested individuals who will be the voice for their neighbors and act as champions for the community transportation projects.



#### Community Engagement

We will meet with the communities to gather information and cultivate meaningful conversations.



#### Surveying the Public

This website will host a survey and interactive maps to collect feedback from the East Knox County communities.



#### **Data Integration**

Existing conditions and community input will be combined to complete a picture of East Knox County's transportation needs. Based on this, a new project list will be drafted.



#### Project Prioritization

After completing the list of projects, additional meetings will be held with the stakeholder groups to ensure the most impactful projects receive attention and resources.


